Introduction of a Cash Management Fee

Platformplus Super Wrap will introduce a Cash Management Fee (the Fee), which will apply from 25 April 2024. The details of the Fee are as follows:

Type of Fee or Cost	Amount	How and When Paid
Cash Management Fee	Estimated to be 0.55% p.a. of your Cash Account balance. Any RITC related to the amount will be retained to the Fund.	The Cash Management Fee is calculated daily and deducted monthly in arrears from interest earnings received prior to allocating interest to your Portfolio. It is not deducted from your Cash Account.
